Re: Violations of the new UN Flag Code by the so-called "United Nations Command"

Dear Secretary-General Guterres,

We are writing on behalf of the International Association of Democratic Lawyers (IADL), a non-governmental organization in consultative status with ECOSOC, the Confederation of Lawyers of Asia and the Pacific (COLAP), and other concerned civil society groups in the world (the list is at p. 3).We found out recently that the United Nations Flag Code was significantly revised in November 2020, as published in the Secretary-General's Bulletin (ST/SGB/2020/4).We welcome this revision of the 1967 Flag Code, which was quite outdated and unclear, and would like to express our thanks to you for your leadership in this matter.

At the same time, we would like to inform you again that there is a continuing abuse of the UN flag by the so-called "United Nations Command" ("UNC"), which is not a UN entity under control of the United Nations, in South Korea and Japan today, in violation of the new UN Flag Code. In particular, we would like to share the following samples as the most serious violations of the new UN Flag Code by the bogus UN military entity:

- 1. Article 8.4 of the new Flag Code prohibits as follows: "*No mark, insignia, letter, word, figure, design, picture or drawing of any nature shall ever be placed upon or attached to the flag.* "However, the "UNC" created its own Website sometime in 2020, including its own military command logo for the first time: using a circle around the UN flag with the words "United Nations Command" on top and 16 stars in the bottom part of the circle. In addition to the "UNC" logo, the "UNC" is also using several other similar logos with different words such as "United Nations Command, Military Armistice Commission," and "JSA". (*See* www.unc.mil; Exhibit A) Thus, by continuing its use of these logos, the "UNC" is in violation of Article 8.4 of the new UN Flag Code.
- 2. Article 8.3 of the new Flag Code also prohibits as follows: "The flag should not be affixed in any manner on any article of any kind which is not strictly necessary to the display of the flag itself." However, the U.S. soldiers associated with the "UNC" are still using the UN flag design/insignia affixed on their hats, masks, and uniforms, in violation of the new Flag Code. The U.S. officers of the "UNC" also affixed the UN flag their www.usfk.mil, 2021; Exhibit on car. (See 2 July B).

Article 6.2 of the new Flag Code requires organizations and individuals who want to use the UN flag to meet certain conditions, including "such a display of the flag: (a) does not suggest any affiliation between the United Nations and the organization...displaying the flag;"(underline added for emphasis) However, in violation of the Article 6.2 of the new Code, the "UNC" is using the UN flag with the U.S. and ROK flags at such places like Camp Humphreys - a major U.S. military base where the "UNC Headquarters" is located - in Pyongtaek, military guard posts in the southern parts of the DMZ, etc., while the "UNC-Rear" is flying the UN flag with the U.S. military's continuing use of the "UNC" logos, mask, hat, shoulder patch, etc., as explained in Point 1 and 2 herein, also violate Article 6.2(a) of the new Code. They create a false impression that the U.S.-led "UNC" is somehow affiliated with the UN.

Therefore, we are deeply concerned with the extensive and flagrant violations of the new UN Flag Code that are taking place in South Korea and Japan by the so-called "UNC." If these violations are not stopped by the UN in the near future, it is most likely that they will seriously undermine the dignity and respect of the United Nations in the international community.

Thus, we would like to urge you to designate a responsible UN officer or unit to launch a comprehensive investigation into the current situation of wide-spread violations of the new UN Flag Code by the fake "UNC," and take necessary measures to stop the continuing abuse of the UN flag in South Korea and Japan.

We would appreciate your attention in this matter and kind response as soon as possible. Please do not hesitate to contact us if you need further information on this matter.
